The fundraising effort for this project has been extremely successful and the ACKMA contribution was completely unexpected. The success of this project has only been possible due to the dedication and belief of the Rimstone Cooperative membership and the extended caving community of Australasia.

Although, there is a small amount of capital still to pay off, Rimstone is now turning to the challenging management side of a rural caving property. We are now working on protecting the cave and enhancing the surface karst, including the tufa terraces and orthor property management issues such as weed control. We aim to have the property an example of sustainably managed karst farmland, accessible by arrangement for cave and karst investigations and recreational caving.
